DIRECTIONS:

FROM THE EAST: Take Elgin-Ohare Expressway west, Exit Lake St / IL rte. 20, head west 14 miles, Turn left onto Plank Rd. Continue 10.6 miles, Turn right onto Engel Rd. Cross over the railroad tracks and make a left into the Forest Preserve entrance.

FROM THE WEST: Take Illinois toll way 88 east; take exit onto Peace Rd in DeKalb. Drive 15.6 miles. Turn left onto Engel Rd. Cross over the railroad tracks and make a left into the Forest Preserve entrance.



The test secretary shall then notify all entries of the results of the draw. In the event an accepted entry is absent on the day of the test, it shall be the responsibility of the Test Secretary to determine if alternates are present and to determine, by their position on the alternate list, which of the alternates shall participate.

The assignment of dogs to the tracks, by the drawing of lots, is the responsibility of the judges.

ATTENTION EXHIBITORS

With the entry form in the TD Test of the dog, which has not passed a "Tracking Test", there must be filed a written statement by a person who is accredited by the American Kennel Club to judge a "Tracking Test", that the dog is considered by the judge to be ready for such a test. The holding of other titles including "TD" shall not bar a dog from competition in the TD test. Entries without a Tracking Dog Title (TD) will be accepted first. In the TDX portion of the test, entries without a Tracking Dog Excellent Title (TDX) will be accepted first.

There will be no actual scores for the tracking test, but the dogs will be rated "Passed" or "Failed" and an appropriate certificate will be issued by the American Kennel Club confirming all dogs rated "Passed".

TELEGRAPH, telephone and unsigned entries cannot be accepted. Entries not on Official AKC Entry Forms and photocopies of entry forms without Agreement and Rules on the reverse side of the Official AKC Entry Form are NOT ACCEPTABLE.

ENTRY FEE for TD is \$75.00 (includes 50 cents Recording Fee). ENTRY FEE for TDX is \$120.00 (includes 50 cents Recording Fee) made payable to Lyons Township Dog Training Club, Inc. A Recording fee of 50 cents and event fee of \$3.00 will be required for each dog entered at any licensed or member club show, or obedience trial or tracking test. This recording fee is to be collected by the show giving club and paid to the American Kennel Club. If a dog is entered in more than one class in the show, the recording fee is to be collected on the first entry only. Entry fees will be refunded within seven (7) days after completion of the Test in the event all tracks have entries or alternates have replaced entries. No entry fee will be refunded if the request is made after closing date and all tracks are not used. ENTRIES cannot be accepted, canceled, altered or substituted after the entries close with the test secretary.

THE Tracking Test is limited to 4 dogs. The Tracking Dog Excellent Test is limited to 4 dogs. In accordance with the AKC Obedience Regulations (AKC Rule, Chapter 1, Section 26a) entries in this TD/TDX Test shall be accepted up until the official closing date, even though the advertised limit has been reached. A drawing will be held on Thursday, April 18, 2019 at the secretary's home at 7:00 pm to determine which entries will participate in the tests. This drawing shall be completely random among all entries received except that preference shall be given to dogs, which have not earned TD or TDX titles.

SPECIAL NOTICE- At a combined TD/TDX test, if the limit for entries is not reached in one test and the limit for entries is exceeded in the other test, the number of tracks may be exchanged up to a maximum of twelve (12) TDs or six (6) TDXs. When the advertised limit has been drawn, all remaining entries, subject to the same preferences set forth above, shall be similarly drawn and assigned a position on an alternate list.
